- 2. In case a request is received by the Bureau of Standards from a school library or a teacher, for pamphlets to be preserved for the general use of pupils, the Bureau will be pleased to give careful consideration to such requests in connection with the distribution of a very limited official edition of these publications.
- Circular No. 1 "The National Bureau of Standards " Gives general information concerning the organization, functions, and work of the Bureau. Cites accomplishments and includes illustrations typical of work in laboratories and facilities for same. 84 illustrations. 113 pages. 50ϕ .
