



GENERAL INFORMATION

The following reports, covering results of laboratory tests and other investigations conducted at the National Bureau of Standards, contain technical information on the engineering properties of building materials, structural elements, and equipment used in house construction.

They may be obtained from the Superintendent of Documents, Government Printing Office, Washington, D. C. at prices indicated unless out of print*. The prices quoted are for delivery to addresses in the United States and its territories and possessions and in certain foreign countries which extend the franking privilege. In the case of all other countries, one-third the cost of the publication should be added to cover postage.

If you wish to receive the reports immediately upon their release, a deposit of \$5.00 may be made with the Superintendent of Documents against which their cost will be charged until this amount is exhausted. If 100 copies or more are ordered at one time, a discount of 25% will be allowed.

If you desire to be notified when new reports are issued, you may advise the Superintendent of Documents to that effect and notices will be sent to you without charge.
