LIST OF PUBLISHED ...TERIAL RELATING TO BUILDING REGULATION

This list is intended to be of assistance to those interested in studying, developing, or revising building and plumbing regulations. It includes publications issued by the National Bureau of Standards and material issued under the procedure of the Derican Standards Association, with which the Bureau cooperates in the development of building code standards.

Where prices are shown, the Bureau publications may be obtained from the Superintendent of Documents, Government Printing Office, Washington 25, D.C. The prices quoted are for delivery to addresses in the United States and its territories and possessions and in certain foreign countries which extend the franking privilege. For all other countries, one-third the cost of the publication should be added to cover postage. Prepayment is required and should be made either by coupens, obtainable from the Superintendent of Documents in sets of 20 for pl.00 and good until used, or by check or money order payable to the Superintendent of Documents. An order blank for government publications will be found at the end of this list.

Publications marked "OP" are out of print but, in general, may be consulted in technical libraries.

Preparation and revision of building codes. G. F. Thompson.

Presents information for the use of local committees charged with the responsibility of preparing or revising building codes. This is drawn from material accumulated at the National Bureau of Standards over a period of years in connection with development of recommended building code requirements. Covers the influence of the building code on the community; the basic principles involved; deficiencies evident in existing codes; methods of arrangement, numbering, and presentation; and the use of national standards. Gives references to sources of technical information and to articles by various authorities on the subject. Ilso gives extracts from local codes, to illustrate various ways of dealing with major problems.

Building code requirements for new dwelling construction. (1947).

Presents recommendations of the Mational Housing Agency prepared in consultation with the National Bureau of Standards. Applies to single- and two-family houses and multiple dwellings of limited height; cites certain well-developed standards as acceptable good practice; and provides for recognizing new developments in the building field. (Supersedes BMS88)

Presents a list of publications giving results of tests and other pertinent information relative to material used in construction. (Supersedes LC290)

A complete set of minimum requirements for masonry construction, including materials and allowable stresses and general requirements for all types of masonry except reinforced masonry.

Fire-resistance classifications of building constructions.

Presents information on the application of classifications of building construction to the fire severity obtaining for given structural and occupancy conditions; discusses types of restrictions and limitations generally incorporated in building codes; gives results of surveys of combustible contents of buildings housing typical occupancies as a basis for estimation of fire severity; gives fire-resistance ratings of building constructions and fire-resistance classifications of roofing materials.

Fire tests of wood- and metal-framed partitions. (1941). 5lp.

Presents results of fire tests of partition constructions representative of a wide range in materials and design and in terms of performance under recognized testing procedure.

American standard building code requirements for minimum design loads in buildings and other structures. (Propared under the procedure of the imerican Standards Association, the National Bureau of Standards acting as sponsor.) (1945). 32p. 3 illus. M179 10¢

Presents requirements covering dead, live, ind, and earthquake lo ds. Information intended t assist local committees and officials in applying the requirements is given in an appendix.

Minimum live loads allowable for use in design of buildings.

(1924). 38p., - - - - - BH7 OP

Presents recommended minimum live loads to be assumed as the basis for building design; together with much information on the floor loads characteristic of different occupancies or resulting from storage of different commodities.

Report includes material on wind pressures, impact allowances, and administration of live load requirements in building codes.



Presents recommendations regarding lipe sizes, precautions against pollution of water supply, types of venting, and other matters usually covered in plumbing codes; and gives information useful in applying the recommendations. Prepared by a committee composed of representatives of Federal agencies after consideration of extensive experimental work and other information available since BH13 was issued. Useful as a reference in connection with development of local plumbing codes.
