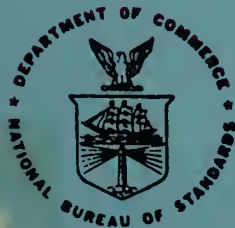

## Introduction

On January 1, 1980 the Multilateral Trade Negotiations Agreement on Technical Barriers to Trade (popularly known as the Standards Code) went into effect. The Code is administered by the Secretariat of the General Agreement on Tariffs and Trade (GATT) in Geneva, Switzerland. As a signatory<sup>1</sup> to the Code, the United States has established several programs to implement its provisions. One such program deals with the Code's requirement that signatories be informed of proposed government regulations (standards or certification systems) that might affect international trade.

This report describes the GATT notification activities performed by the Standards Code and Information (SCI) program, National Bureau of Standards (NBS), for calendar year 1982. The U.S. Department of Commerce designated NBS as the official U.S. inquiry point for information on standards and certification activities.<sup>2</sup> NBS' responsibilities include notifying the GATT Secretariat of proposed U.S. Federal Government rules that may significantly affect trade; maintaining information on similar notifications made by other signatories; and responding to inquiries on both foreign and U.S. notifications. Detailed summaries of NBS' GATT notification activities are prepared monthly and are distributed to the appropriate NBS managers<sup>3</sup> and other Federal Government agencies involved in the Code's implementation.

The GATT Secretariat issued 202 notifications in 1982. Twenty of the thirty-six signatories sent the Secretariat at least one notification (see Table 1). Japan had the most notifications (47). Three other signatories - - Canada, Sweden and the United States - - issued 20 or more.

A major objective of the Code is to enable exporters to comment on foreign regulations they feel would unjustifiably impede the export of their products. In an effort to publicize available information, all foreign notifications are currently published in the Commerce Business Daily, the Department of Agriculture's Export Briefs and several other newsletters. The notifications of proposed foreign regulations are received in English, but the full text of the regulation is usually in the language of the issuing country

In 1982, NBS established several new activities to improve the current program and provide additional services:

- o a computerized data system for monitoring GATT notifications and inquiries;
- o a translation service, on a shared-fee basis, to provide English versions of the full texts of foreign proposed regulations if requested, and
- o a hotline number to call for up-to-date notification information. The "hotline" number is (301)921-3200 and is not toll-free.

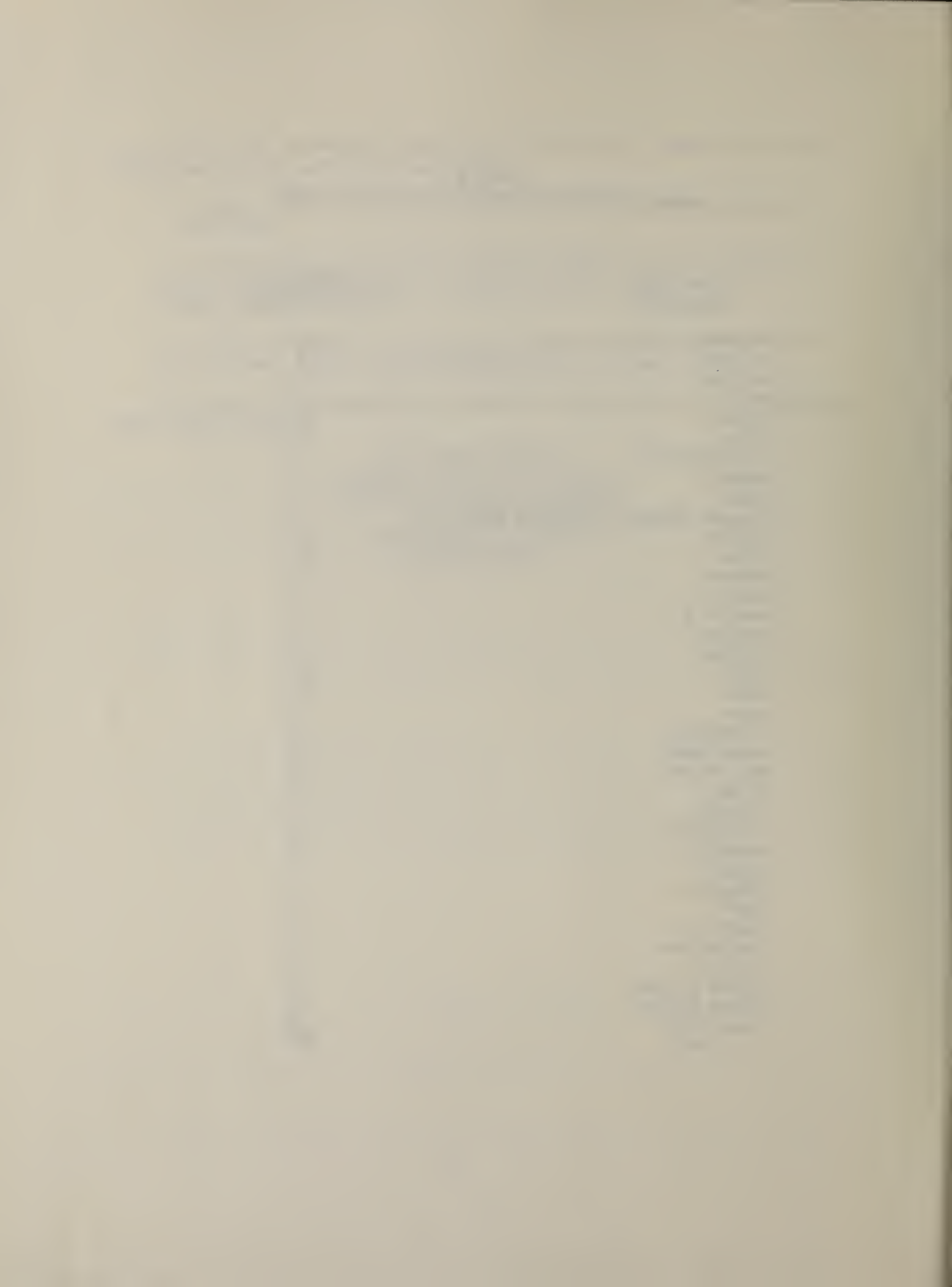

## Notifications of Proposed U.S. Regulations

Notifications sent to the Secretariat are based on proposed U.S. government rules (mandatory standards or certification systems) published in the Federal Register (FR). The FR is reviewed daily by NBS staff to identify those regulations that may significantly affect trade. If there is a question about the impact of a regulation, appropriate Federal Government agency experts are contacted for concurrence before a notice is sent. Notices are sent directly to the Secretariat via telex once a week.

All notifications are assigned a control number by NBS staff for internal tracking purposes. The GATT Secretariat assigns a Technical Barriers to Trade (TBT)/Notification (Notif.) number so that signatories can identify specific regulations. The Office of the U.S. Trade Representative in Geneva cables the TBT/Notif. number, date of issuance and control number to the U.S. agencies responsible for Code implementation (see page 1).

During 1982, 24 proposed U.S. rules were reported to the GATT Secretariat. The Secretariat issued these notifications plus an additional one sent at the end of 1981, for a total of 25.

The Environmental Protection Agency and the Department of Transportation's National Highway Traffic Safety Administration each had 7 of the notifications issued. The 25 regulations reported dealt with such products as motor vehicles, chemicals, clothing, and electrical equipment.

Table 2 itemizes all U.S. notifications. The number of notifications per agency was:

In 1981, the United States reported 91 regulations to the GATT Secretariat. The significant decrease in 1982 was due, at least in part, to current Administration policies concerning new regulations and EPA's view that many pesticide and other regulations, which had previously been reported, were not trade significant.

## Notifications of Proposed Foreign Regulations

The GATT Secretariat issued 177 foreign notifications in 1982 (see Table 3). A breakdown by country is listed in Table 1.

The Office of the U.S. Trade Representative in Geneva cables the contents of the notifications (which includes country, TBT/Notif. number, brief description of the regulation, and closing date for comments, but not the full text) to the U.S. as soon as they are received from the Secretariat. The notified regulations covered a wide variety of products. Some of the more common product categories were: weighing machines, asbestos, electrical equipment, drugs, chemicals, motor vehicles, food and food products, medical equipment, and appliances. A file is maintained by a SCI staff member on all products that are the subject of foreign notifications. This file also records the names and addresses of individuals interested in specific products not the subject of notifications. When a notification concerning a particular product arrives, all individuals who have indicated an interest are contacted.

Foreign notifications are also sent regularly to the American National Standards Institute, the Bureau of Industrial Economics (Commerce Department), Industry Functional Advisory Committee members, selected representatives on the Interagency Committee on Standards Policy, and several other groups and individuals for dissemination or publication.

### Text of the Regulations

In 1982, the texts of all foreign regulations were requested by SCI staff and received from the appropriate inquiry point. Of the 177 regulations reported, 126 were not in English. The following signatories always provide their regulations in English: Canada, EEC, Hong Kong, Ireland, New Zealand, Philippines, United Kingdom, and Singapore. SCI has arranged for a translation service to provide English translations of proposed foreign regulations. The cost of the translation is paid for by the requestor; if more than one person requests a translation, the cost is shared.

## Comments on Proposed Foreign Regulations

Manufacturers and exporters, as well as government agencies, are provided with an opportunity to review and comment on proposed foreign regulations, especially if there is likelihood that the regulations would disadvantage U.S. exporters.

U.S. government or business organizations commented on three proposed foreign regulations notified through the GATT Secretariat in 1982:

82.84 Japanese ban on the food additive BHA

82.98 United Kingdom on telecommunications attachments

82.186 Swedish revision of their ordinance on foreign substances in food

SCI staff are responsible for coordinating comments made by U.S. manufacturers on specific proposed foreign regulations and transmitting them to the appropriate foreign government. Limited resources are available to assist U.S. companies in developing their comments and in determining whether a technical trade barrier exists.



## Inquiries

In 1982, 478 inquiries for GATT notification information (401 U.S., 71 foreign) were processed, an increase of 112 over 1981. These numbers reflect the number of letters and/or telephone calls received. Many requestors asked for copies of more than one regulation. In addition to requests for specific foreign regulations, many individuals asked for general information on the Standards Code. NBS responds to these individuals by sending an information package consisting of a list of recent foreign notifications, a brochure on the Multilateral Trade Negotiations (MTN) Agreement on Technical Barriers to Trade, and subscription information for the Commerce Business Daily.

Most inquiries are answered within 1-2 days, depending on the availability of the regulation. Requests from foreign countries for proposed U.S. regulations (copies of the Federal Register notice) are answered the same day.

U.S. exporters were most interested in regulations from Canada, Finland, France, the EEC, Japan, and Sweden. The most requested regulations dealt with televisions, machine tools, drugs, appliances, electrical equipment, food additives, dangerous substances, and motor vehicles. Foreign exporters were primarily interested in electrical equipment, meat products, pesticides, chemicals, and motor vehicles.

In its first six months of operation (July - December), the GATT hotline received 996 calls from individuals interested in foreign regulations and Standard Code activities.

### Comment Periods

To provide signatories with the opportunity to receive the text of a regulation, review it, and prepare comments, the Standards Code recommends a comment period of at least 45 days. In 1982 the average length of the comment period\* for U.S. regulations was 50 days; for foreign regulations 44 days. Table 4 lists all U.S. regulations and the length of comment period for each. The average length of comment period\* by U.S. agency was:

### Recapitulation

The total number of notifications decreased from 295 in 1981 to 202 in 1982. At the same time, however, the number of inquiries increased from 366 to 478, reflecting a growing interest by U.S. industry in foreign regulations and standards activities. The time available for comments on foreign regulations did not change significantly in 1982, averaging only one day longer.

Based on current U.S. deregulatory policy, the number of proposed U.S. regulations to be notified to the GATT Secretariat will probably continue the decline observed in 1982. NBS will not only continue to provide individuals with prompt and accurate information on proposed foreign regulations, but will also attempt to encourage wider review and more comments on them from interested parties.
