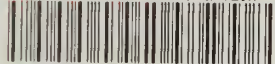

ABSTRACT

This report describes the GATT Standards Code activities performed by the Standards Code and Information program, National Bureau of Standards (NBS), for calendar year 1984. NBS responsibilities include operating the U.S. GATT inquiry point for information on standards and certification activities; notifying the GATT Secretariat of proposed U.S. Federal government standards-based rules that may significantly affect trade; assisting U.S. industry with trade-related standards problems; and responding to inquiries on foreign and U.S. proposed regulations.

Key Words: foreign proposed regulations; GATT Standards Code; notifications; standards information; technical assistance

INTRODUCTION

The international Agreement on Technical Barriers to Trade (Standards Code) has been in effect since January 1, 1980. There are currently 37 signatories ^{1/} to the Code, 26 of which have actively implemented the Code in their countries. The Code is administered by the Secretariat of the General Agreement on Tariffs and Trade (GATT) in Geneva, Switzerland.

The Office of Product Standards Policy (OPSP) has several responsibilities for implementing provisions of Title IV of the U.S. Trade Agreements Act of 1979 related to establishment of a U.S. inquiry point, ^{2/} standards information center, and technical office for non-agricultural products. This report summarizes Standards Code activities performed by the Standards Code and Information (SCI) program in OPSP for calendar year 1984. These functions are performed within the traditional framework of NBS standards-related programs.

Highlights of 1984 included publication of a directory of standards activities in the United States; development of databases for private sector, Federal, and state certification systems; background research for bilateral standards discussions; participation in an international symposium in Brazil on the Standards Code; publication of a report describing the benefits U.S. industry receives by participating in international standards activities; and initiation of a Foreign Commercial Service orientation program.

INQUIRY POINT

Notifications

Signatories of the Standards Code must notify the GATT Secretariat of all proposed mandatory government regulations and certification procedures that might significantly affect international trade. The Secretariat, in turn, issues notifications of these proposals and disseminates them to all signatories. (Table 1 lists the total number of notifications issued for the past five years.)

As the official U.S. GATT inquiry point for information on standards and certification activities, SCI notifies the Secretariat of proposed U.S. Federal Government rules that might significantly affect trade; receives foreign notifications and disseminates them along with supplementary information to appropriate U.S. companies and industry groups; and responds to inquiries about foreign or U.S. notifications. SCI's GATT notification activities are reported quarterly to cognizant NBS managers and other Federal Government officials concerned with the Code's implementation. ^{3/}

In 1984, the GATT Secretariat issued 223 notifications. Twenty-two of the 37 signatories reported at least one proposed regulation (see Table 2). Japan had the most notifications with 34. Seven other signatories - Canada, European Economic Community, Finland, India, Sweden, United Kingdom, and the United States - reported 10 or more proposed regulations.

The USTR Office in Geneva receives notifications from the Secretariat and cables them to the United States. The notifications, which are issued in English, include name of country proposing the regulation; TBT/Notification number; brief description of the regulation; and the final date for comments. In order to provide wide access to this information in the United States, all foreign notifications are published in the Commerce Business Daily, the American National Standards Institute's ANSI Reporter, the Department of Agriculture's Export Briefs, and several other publications. SCI maintains a computerized data base on all GATT notifications and a telephone GATT hotline where up-to-date notification information can be obtained. The hotline number is (301) 921-3200.

Proposed U.S. Regulations

Proposed U.S. Government rules (mandatory standards or certification systems) are published in the Federal Register (FR). SCI staff regularly review the FR to identify those proposed regulations that might significantly affect trade and which, therefore, should be notified to the GATT Secretariat. Notices are sent directly to the GATT Secretariat via telex.

In 1984, 28 proposed U.S. regulations were reported. Twelve of the 28 regulations reported were proposed by the Environmental Protection Agency. The number of notifications from each issuing agency is shown below. The regulations covered such products as food, drugs, motor vehicles and lifesaving equipment (see Table 3).

Proposed Foreign Regulations

The GATT Secretariat issued 195 notifications from countries other than the United States in 1984 (see Table 4). The foreign regulations covered a wide variety of products such as telecommunications equipment, food additives, electrical equipment, appliances and motor vehicles. The SCI inquiry point maintains a Key-Word-Out-Of-Context (KWOC) index on all products that are the subject of foreign notifications (see Appendix 1 for 1984 index). A KWOC is an indexing method in which keywords (in this instance products) appear as headings in a separate line index flush with the left margin. Records are kept of the names and addresses of individuals who have expressed interest in specific products. A notification concerning a particular product is routinely sent to all individuals who have indicated that they wish to be kept informed.

Foreign notifications are sent regularly to the American National Standards Institute, Bureau of Industrial Economics (Department of Commerce), Industry Functional Advisory Committee (IFAC) members,^{4/} selected representatives on the Interagency Committee on Standards Policy (ICSP),^{5/} and several other groups and individuals to serve their information needs and allow them to disseminate or publish as appropriate.

Inquiries

SCI processed 385 letter or telephone requests for GATT notification information (210 U.S., 75 foreign) in 1984. Many requesters asked for copies of more than one regulation. In addition to requests for specific regulations, many individuals asked for general information on the Standards Code. SCI responds to such requests by sending an information package consisting of the latest issue of its newsletter, tbt news, a list of recent foreign notifications, a brochure describing the Standards Code, and ordering information for the Commerce Business Daily.

In 1984, U.S. exporters were most interested in regulations from Sweden, Japan, Canada, Finland and the European Economic Community. The regulations most often requested concerned telecommunications equipment, agricultural equipment, chemicals, food, and motor vehicles. In addition, 428 calls were received on the GATT hotline for up-to-date information on foreign notifications.

Translations

SCI requests the texts of all proposed foreign regulations from the inquiry points of the issuing signatories. A little more than half of the 195 regulations received in 1984 (103) were in languages other than English. SCI has arranged for a translation service which can provide English translations of any proposed foreign regulations. The cost of the translation is paid for by the requester; if more than one request is received for the same translation, the cost is divided equally among the requesters. In 1984, SCI received requests for translations of two regulations.

Other Activities

SCI publishes tbt news, a newsletter intended to inform U.S. industry and other interested groups of the U.S. Government programs and activities in support of the Standards Code. Subscription to the newsletter is free and can be obtained by contacting the SCI office.

STANDARDS INFORMATION

The National Center for Standards and Certification Information (NCSCI) is the national repository for standards documentation. NCSCI supports the GATT inquiry point activities by supplying information concerning both domestic and foreign standards information. NCSCI, which was established in 1965, is designed to meet the needs of government,

industry and the public for information on standards, regulations, certification programs and related activities that affect trade and commerce.

NCSCI's objectives are accomplished by maintaining a microform and hard copy collection of engineering standards and specifications, regulations, certification rules, directories, reference books and special publications. NCSCI staff respond to more than 5000 requests annually from all over the world on the existence, source and availability of standards and related documents. To the degree possible, NCSCI responds to trade-related queries regarding regulations and other requirements of foreign countries for the export of U.S. manufactured products.

In 1984, NCSCI published Standards Activities of Organizations in the United States (NBS Special Publication 681), which replaces the Directory of United States Standardization Activities (NBS Special Publication 617). This directory is an up-to-date guide to mandatory and voluntary standards activities in the United States at Federal and state levels and by nongovernment (trade associations, technical and other professional societies). Over 750 current descriptive commentaries are formatted, with subject headings to facilitate access to specific information. Organizations have been included if they develop standards or contribute to the standardization process, whether voluntary or mandatory, or are sources of standards documents of information. NCSCI is currently developing directories of private sector, federal and state certification programs. These will together constitute the first comprehensive database of this type of information compiled in a single source. Publication of the private sector directory is planned for summer 1985.

TECHNICAL OFFICE

The SCI program performs the technical office functions for non-agricultural products. These include: a) providing assistance to U.S. exporters on specific technically based standards-related trade issues; b) assisting the ITA and USTR in developing technical background for bilateral and multilateral discussions with representatives from other Code signatories; c) monitoring the level of U.S. participation in international standardization activities; d) participating in the Trade Policy Staff Committee's Subcommittee on Standards and the Industry Functional Advisory Committee; e) serving as the focal point for information on international noise standards; and f) coordinating comments on proposed foreign regulations. Technical office staff also assist individuals in determining whether or not a proposed foreign regulation is consistent with current U.S. regulations/standards and international regulations/standards.

Assistance to Industry

Technical office staff work closely with industry representatives to address standards-related trade problems and develop a technical basis for negotiated resolutions. In 1984, the following items were among those receiving attention in work with the private sector:

1. A U.S. manufacturer and exporter of U.S.-produced household hot water heater systems alleged that the United Kingdom enforced regulations that did not recognize hot water heaters of the pressure type produced by the firm and used in most U.S. homes and businesses. Technical office staff developed background information on the problem from locally available sources and contacts with the British Department of Environment and various British Water Boards, through the American Embassy in London.
2. Representatives from the Farm and Industrial Equipment Institute and one of its member firms requested assistance in identifying standards-related trade problems limiting export of U.S. produced agricultural tractors to Japan. Technical office staff prepared a summary analysis of the Japanese Agricultural Mechanization Promotion Law and its implementing regulations, the Organization for Economic Cooperation and Development Tractor Test Code, and similar U.S. requirements. The analysis, forwarded to the groups for further action, presented evidence to support the conclusion that the Japanese requirements were restrictive.
3. As the focal point for the collection and maintenance of information on developments involving international noise standards, technical office staff provided representatives from several industry and trade associations with information on these standards and related development activities.

Other Agency Assistance

The following technical office activities assisted USTR and ITA in developing information for bilateral consultations:

- o to determine the degree of U.S. success in resolving standards-related complaints, the technical office staff analyzed past bilateral standards consultations between the U.S. and several trading partners (Federal Republic of Germany, EEC, United Kingdom, France and Canada). Problems still pending resolution concern agricultural tractors and can sizes for processed food (France), automobiles, metal alloys, and construction machinery (Germany) and cosmetics and earthmoving machinery (EEC);
- o developed guidelines to assist industry in providing pertinent information to the technical office on standards-related trade problems. This information is used to prepare discussion papers for bilateral talks and serve as background for technical analysis;

- o prepared background papers for 1984 bilateral standards consultations with the Federal Republic of Germany and the European Economic Community (specific bilateral issues included autos, asbestos, fertilizer and rail-mounted vehicles (EEC) and plywood, agricultural machinery and micro-wave devices (Germany);
- o organized U.S. response to generic and product specific complaints raised by the Federal Republic of Germany regarding various U.S. standards practices; and
- o prepared technical background information based on analysis of U.S. industry complaints concerning alleged discriminatory practices in the United Kingdom, Federal Republic of Germany and France against U.S. manufactured fire protective coatings and electrical equipment.

Other Activities

In 1984, technical office staff published Benefits Perceived by U.S. Industry from Participation in International Standards Activities (NBSIR 84-2886, May 1984). This report summarizes results of an analysis of major areas of U.S. export trade and the extent of U.S. representation in international standards organizations which are open to U.S. participation.

The government of Brazil hosted an international seminar in September on technical barriers to trade to inaugurate Brazil's emergence as an operating signatory to the GATT Standards Code, inviting experts from Canada, France, Japan, West Germany and the United State to participate. The SCI program manager served as one of the two U.S. delegates and described technical aspects of Standards Code implementation in the United States.

SCI and the Commerce Department's Foreign Commercial Service (FCS) instituted a cooperative arrangement in 1984 to assist FCS officers with standards information and interpretation and, in turn, help SCI locate additional foreign information sources. SCI distributed information packages to all posts and briefed eight FCS officers before they went to their new posts. The briefing sessions included meetings with SCI staff who explained standardization practices in the country of the Officer's assignment and how NBS could assist them in their duties.

At the request of the OPSP Director, technical staff investigated causes for the lack of U.S. participation in standards development activities of ISO Technical Committee 48, Laboratory Glassware and Related Apparatus, between 1971 and 1982. A new U.S. technical advisory group has stimulated new interest and involvement with broad based industry support.

The technical office began a research project in 1984 to compare selected product regulations and standards in several foreign countries to help exporters in identifying and coping with an apparent "maze" of

foreign standards and regulations. The countries selected were Canada, Japan, France, Federal Republic of Germany, United Kingdom, Ireland, India and Philippines. The products are medical products, air conditioners, microwave ovens and hand tools. Unusually long delays in getting copies of the relevant documents and the fact that many of the documents are in a language other than English, are among the problems which will be addressed in an interim report.

Comment Handling

A major objective of the Standards Code is to allow exporters and government agencies to comment on foreign regulations which they feel would unjustifiably impede their country's exports. SCI provides the text of proposed foreign regulations to all interested parties and encourages them to make comments if the regulation might create unnecessary trade barriers. SCI transmits the comments to the appropriate foreign government and coordinates any follow-up activity. In 1984, SCI handled comments on two foreign regulations: - EEC - rail mounted vehicles (84.11) and Sweden - cosmetic or hygienic preparations (84.119). Informal comments are frequently made by industry representatives who become aware of proposed regulations even before they are notified through the GATT. Some of these representatives use the notification system as a follow-up means of ensuring awareness of foreign developments.

Comment Periods

To provide signatories with adequate time to receive the text of a regulation (and to translate it if necessary), review it, and prepare comments, the Standards Code recommends a comment period of at least 60 days. If the comment period is insufficient (e.g., due to late receipt of an English version or complicated technical issues), the technical office will request that the issuing country extend the comment period. In 1984, nine such requests were made and granted. In many cases extensions are requested to enable individuals to translate and study the regulation and do not necessarily indicate that comments will be made.

The average length of the comment period 6/ in 1984 was 37 days for U.S. regulations and 47 days for foreign regulations. (In comparison, the corresponding averages for 1983 were 41 and 45.) Table 5 lists all U.S. regulations and the length of the comment period for each. The average length of comment period by U.S. agency was:

Comment period for foreign regulations ranged from none at all to 227 days. Table 6 lists all foreign regulations for which notifications were received and the length of comment period for each. The average length of comment period by country was:

Future Activities

SCI will continue to work with U.S. industry to assist them in solving standards-related trade problems and to make sure they receive relevant notifications on proposed foreign regulations which may affect trade. SCI also plans to continue developing databases on pertinent certification systems, updating the index of U.S. voluntary standards (SP329), and preparing background research for bilateral standards discussion. Activities are planned to assist developing countries in establishing or improving standards information exchange programs.

¹ /As of December 1984, the signatories are: Argentina, Austria, Belgium, Brazil, Canada, Chile, Czechoslovakia, Denmark, Egypt, European Economic Community (EEC), Finland, France, Germany, Greece, Hong Kong, Hungary, India, Ireland, Italy, Japan, Korea, Luxembourg, Netherlands, New Zealand, Norway, Pakistan, Philippines, Romania, Rwanda, Singapore, Spain, Sweden, Switzerland, Tunisia, United Kingdom, United States and Yugoslavia.

² /The Code requires that each signatory provide an inquiry point to answer all reasonable inquiries on technical regulations, standards and certification systems.

³ /Other Federal offices with Standards Code responsibilities are located in the International Trade Administration (ITA) (Department of Commerce), Office of the U.S. Trade Representative (USTR), and the U.S. Departments of Agriculture and State.

⁴ /The IFAC is comprised of representatives from private industry engaged in standards-related activities. It advises the Department of Commerce and USTR on trade matters, the operation of any adopted trade agreements and other subjects related to U.S. trade policy.

⁵ /The ICSP consists of senior executives from 26 Federal Government agencies. It is concerned with facilitating the effective participation by the Federal Government in domestic and international standards activities and promoting the development of uniform policies among agencies participating in these activities.

⁶ /Number of calendar days between the date the notification was issued by the GATT Secretariat and the closing date for comments.
