

INTRODUCTION

Each member of the World Trade Organization (WTO) is responsible for the obligations set forth in the Agreement on Technical Barriers to Trade (TBT Agreement). As of December 31, 1996, there were 128 WTO members (see Table I). The National Center for Standards and Certification Information (NCSCI), within the Office of Standards Services, is responsible for many provisions which relate to the establishment of a U.S. inquiry point, a standards information center, and other non-agricultural standards activities. Seventy-three WTO members had established inquiry points in 1996. This report summarizes TBT Agreement activities conducted by NCSCI during calendar year 1996.

INQUIRY POINT

Notifications

WTO members are required to notify the WTO Secretariat of all proposed government regulations and conformity assessment procedures that might significantly affect international trade. The Secretariat, in turn, disseminates the notifications to all other members. As the official U.S. WTO/TBT inquiry point for information on standards and conformity assessment activities, NCSCI notifies the Secretariat of proposed U.S. Federal Government rules that might significantly affect trade. NCSCI also receives foreign notifications through the WTO Secretariat and disseminates them, along with supplementary information, to appropriate U.S. companies and industry groups. NCSCI responds to inquiries about foreign and U.S. notifications, provides copies of the proposed regulations, and arranges for fee-supported translations of foreign standards. Center staff also assist in developing comments on the impact on U.S. industry of proposed foreign regulations and transmits them to the foreign government concerned.

In 1996 the WTO Secretariat issued 460 notifications. Thirty-two WTO members each reported at least one proposed regulation (see Table II.) The European Community (EC²)

had the most notifications (47). Sixteen other signatories - Australia, Belgium, Canada, Czech Republic, Denmark, India, Japan, Malaysia, Mexico, Netherlands, Norway, Philippines, Sweden, Switzerland, Thailand and the United States - each reported 10 or more proposed regulations.

An official in the Office of the U.S. Trade Representative (USTR) in Geneva receives notifications from the WTO Secretariat and transmits them directly to the United States. The TBT notifications, all of which are available in English, include the name of the country proposing the regulation; the assigned Goods/Technical Barriers to Trade/Notification (G/TBT/Notif.) number; a brief description of the regulation; and the final date for comments (see Appendix A). In 1996, the TBT notification documents were derestricted to encourage wider distribution by members.

In order to provide wide access to this information in the United States, all foreign notifications are published in the *Commerce Business Daily* and several other U.S. publications. NCSCI maintains a computerized database on all TBT notifications and a telephone WTO hotline where up-to-date notification information can be obtained. <u>The hotline number is (301) 975-4041</u>.

Proposed U.S. Regulations

All proposed U.S. Government rules (mandatory standards or conformity assessment systems), including proposed revisions, are published in the *Federal Register* by the responsible Federal agency. Center staff regularly review the *Register* to identify those proposed regulations that might potentially affect trade, and therefore should be notified to the WTO Secretariat. Notices of these proposals are sent directly to the WTO Secretariat via fax.

To fulfill the obligation requiring members to notify proposed local government regulations, NCSCI contracted with a private company to review state journals to identify proposed trade-related technical regulations. In 1996, twenty one states³ were targeted, but no proposals were identified.

In 1996, thirty-eight proposed U.S. regulations were reported to the WTO Secretariat covering such subjects as food labeling, textile apparel, lamps, drug products, and motor vehicles. (NOTE: Thirty-six of the thirty-eight proposals were issued as formal G/TBT/Notifications in 1996, the other two were issued in 1997.) The originating agencies for the TBT regulations are shown below. (See Table III for listing of specific products by agency.)

Proposed Foreign Regulations

The WTO Secretariat in 1996 issued 424 TBT notifications from countries other than the United States (see Table IV.) The foreign regulations covered a wide variety of products, including appliances, construction materials, detergents, food, life rafts and telecommunication equipment. A subject listing of foreign TBT notifications is contained in Appendix B.

NCSCI regularly sends foreign notifications to groups and individuals to serve their information needs and to allow them to disseminate this information to others. The Center also sends copies of all foreign notifications to the American National Standards Institute for publication in its biweekly *Standards Action*.

<u>Inquiries</u>

NCSCI responded to 306 domestic and foreign written and telephone requests for TBT notification information (165 U.S., 141 foreign) in 1996. Many requestors asked for copies of more than one regulation. In addition, a number of requestors asked for general information on the TBT Agreement. NCSCI responds to such requests by sending an

information package consisting of the latest issue of: its newsletter, *TBT News*; a list of recent foreign notifications; brochures describing the TBT Agreement; and ordering information for the *Commerce Business Daily*.

In 1996, the most often requested regulations concerned electrical equipment and appliances, consumer goods, packaging and labeling requirements, and telecommunication equipment. Inquiries are received from a variety of companies and organizations, such as Hewlett Packard, Harley Davidson, AT&T, American Trucking Association, Caterpillar, American Boat and Yacht Council and ACTS Testing Laboratories. The Center also receives requests from individuals who serve as consultants or obtain information for their own use. The types of requests vary as widely as the products subject to notification. Some companies are interested in certain subject or product areas (e.g., telecommunications equipment, cosmetics, ships, consumer appliances, and chemicals); others are interested in specific countries (e.g., Mexico, Japan, Korea, Brazil and the EC).

The information is used by these groups as: 1) an alert system of proposals of interest to them; 2) a mechanism to review a proposal to ascertain its trade impact; 3) an opportunity to comment on a document; and 4) a method for verifying information received from subsidiaries or agents in a foreign country.

Translations

Upon request, NCSCI will ask for the text of the proposed foreign regulations which are subject to notification. WTO members are required to supply copies of the regulations through their inquiry points. Of the 204 proposed regulations requested and received by NCSCI in 1996, 52 were in languages other than English. NCSCI coordinates a service to obtain, on request, an English translation of any proposed regulation in a foreign language. The cost of translation is paid by the requestor; if more than one request is received for the same translation, the cost is divided equally among requestors. The cost of a translation is determined by the number of words contained in the document and the price per 1,000 words charged by the contractor. In 1996, the Center coordinated the translation of three foreign documents.

Comment Handling

A major objective of the TBT Agreement is to allow exporters, government agencies, and other interested parties to comment on proposed foreign regulations which they believe would impede exports. NCSCI provides the text of proposed foreign regulations upon

request and encourages the submission of comments if a regulation appears to create trade barriers. Industry representatives often become aware of proposed regulations through contacts with their foreign counterparts or subsidiaries, and are able to provide informal comments directly to the relevant country.

NCSCI has procedures to transmit comments, upon request, from U.S. organizations to appropriate foreign governments and coordinates any follow-up activity. In 1996, the Center received and processed formal comments from U.S. industry on a proposed Mexican regulation dealing with perfuming and beauty products (G/TBT/Notif. 96.286) and a draft Indian regulation on cosmetics (G/TBT/Notif. 96.256). Companies are free to comment directly to the foreign ministry responsible for the regulation and often do.

The Center also handles comments from foreign countries on proposed U.S. technical regulations reported to the WTO Secretariat. NCSCI staff forward comments to the appropriate U.S. Federal government agency for their consideration. In 1996, comments were received from: the Netherlands on a draft Customs (Treasury) regulation on country of origin (G/TBT/Notif. 95.348); the EC on FDA regulations on food (G/TBT/Notif. 95.335), tea (G/TBT/Notif. 96.46), and prunes (G/TBT/Notif. 96.167) and a proposed FTC regulation on textiles (G/TBT/Notif. 96.20); and Egypt on a proposed USDA regulation on limes (G/TBT/Notif. 96.297).

Comment Periods

To allow WTO members adequate time to receive the text of a regulation (and to have it translated, if necessary), review it, and prepare comments, the Committee on Technical Barriers to Trade recommends a comment period of at least 60 days. If the comment period is insufficient (e.g., due to late receipt of an English version or complicated technical issues), NCSCI staff will request that the issuing country extend the comment period. In 1996 Center staff received twenty-nine requests from other WTO members requesting extensions of the comment period for proposed U.S. technical regulations. In most cases, no formal extensions of the comment periods were made. The Center also requested an extension of the comment period for eight proposed foreign regulations four requests for extensions were granted. Most U.S. regulatory agencies and foreign ministries will accept comments if received within a reasonable time after the final date for comments.

The average length of the comment period⁴ in 1996 was 41 days for U.S. regulations and 43 days for foreign regulations. The average length of the comment period allowed by U.S. agencies is as follows:

Comment periods for foreign regulations ranged from none at all to 107 days. The average number of days for comment period by country was: Argentina, 0; Australia, 45; Belgium, 0; Botswana, 10; Brazil, 13; Canada, 40; Colombia, 0; Czech Republic, 38; Denmark, 60; EC, 47; El Salvador, 57; Finland, 67; France, 60; Germany, 59; Hong Kong, 70; India, 23; Jamaica, 0; Japan, 55; Korea, 20; Macau, 0; Malaysia, 38; Mexico, 55; Netherlands, 43; New Zealand, 24; Norway, 53; Philippines, 33; Slovak Republic, 83; Spain, 37; Sweden, 61; Switzerland, 56; and Thailand, 16.

STANDARDS INFORMATION

NCSCI is the focal point in the United States for standards-related information. The Center, established in 1965 and mandated by the Trade Agreements Act of 1979, provides government, industry, and the general public with information on standards, technical regulations, conformity assessment procedures, and related activities that affect trade and commerce. A brochure describing NCSCI activities is available upon request.

NCSCI maintains a microform, CD-ROM and hard copy collection of engineering standards and specifications, test methods, regulations, certification rules, directories, reference books, and special publications. In 1996, NCSCI staff responded to requests from all over the world on the existence, source, and availability of standards and related documents. NCSCI also responds to trade-related queries regarding regulations or other requirements imposed by foreign countries that affect the export of U.S. manufactured products.

In April, NCSCI hosted a training seminar on standards information sponsored in cooperation with the Commercial Law Development Program, Department of Commerce,

for representatives from Russia, the Ukraine, Romania and Lithuania. The seminar covered the establishment of a national standards information center and responsibilities of WTO inquiry points.

NCSCI staff participated in an Organization of American States - Free Trade Area of the Americas seminar on standards and technical barriers to trade in Montevideo, Uruguay. The seminar, hosted by the Latin American Integration Association, included presentations on the principles of the TBT Agreement and operation of WTO inquiry points, accreditation and certification activities, establishment and operation national standards information centers, and the International Organization for Standardization (ISO) information network and information center. Representatives from the following countries attended: Argentina, Bolivia, Brazil, Chile, Ecuador, Mexico, Paraguay, Peru, Uruguay, and Venezuela. Experts from the WTO Secretariat and ISO also participated.

NCSCI maintains an EC hotline to report on draft CEN and CENELEC standards which may affect trade. The recorded hotline - (301) 921-4164 - is updated weekly and provides the subject/product areas, document number, and final date for comments.

RELATED PROGRAMS

The Office of Standards Services (OSS) provides technical support on non-agricultural standards-related issues. Office functions include: a) participation in standards-related conferences; b) technical assistance to the International Trade Administration of the Department of Commerce and the Office of the U.S. Trade Representative in developing proposals to enhance the TBT Agreement; and c) preparation of special reports on standards issues. 1996 activities included:

- continued participation by office staff in meetings of the Committee on Standards Related Measures to oversee implementation of the standards obligations under the North American Free Trade Agreement (NAFTA);
- participation in the Asia-Pacific Economic Cooperation (APEC) standards and conformance subcommittee and the Free Trade Area of the Americas (FTAA) working group on standards and technical barriers to trade;
- guidance to NIST standards experts assigned to foreign countries (Argentina, Belgium (European Union), India, Japan, Mexico, and Saudi Arabia) and support to training programs of foreign groups from various industry sectors;

- coordinating the standards program of the Special American Business Internship Training program for the Newly Independent States;
- numerous presentations and speeches made by technical office staff regarding standards and international activities;
- liaison with the Industry Functional Advisory Committee on standards, which advises the government on standards-related policy issues; and
- chairing the Interagency Committee on Standards Policy which provides guidance to Federal agencies in the area of standards policy.

CONCLUSION

NCSCI continues to work with U.S. industry to address standards-related trade questions and concerns to assure wide distribution of relevant notifications of proposed foreign regulations which might affect trade.
